

**REBUILDING TOGETHER
ACKNOWLEDGEMENT AND RELEASE AGREEMENT**

I the undersigned, acknowledge that I have voluntarily applied to participate in the Rebuilding Together OKC, Inc. ("Rebuilding Together") Construction Derby® currently scheduled to occur on October 11, 2009. I acknowledge that the date may be changed by Rebuilding Together, in its sole discretion. I further acknowledge that as a participant in the Construction Derby® I will not be covered by any medical or other insurance. I further agree that my participation in the Construction Derby® may be terminated at any time by either Rebuilding Together or me with or without cause. By signing below I agree to the following terms and conditions.

1. I represent and warrant that I am medically able to participate in the Construction Derby® and have no conditions which could impair my ability to operate the vehicle or otherwise participate in any activities necessary for participation in the Construction Derby®.
2. I am aware that by participating in the Construction Derby®, I may be exposed to personal injury or damage to my property as a result of my activities or the activities of other participants and agree to assume any and all risks associated with participating in the Construction Derby® including, but not limited to any injuries that may result from falls, contact with other vehicles or drivers, the effects of weather or the condition of the roads. With knowledge of these dangers, I agree to accept any and all risks of injury or death and verify this statement by placing my initials here: _____

In consideration of the opportunity afforded me to participate in the Construction Derby® I, my assignees, heirs, guardians and legal representatives, agree to and do hereby release and forever discharge Rebuilding Together, its officers, employees, partners, members, attorneys and other affiliates, including Construction Derby® officials, sponsors, and volunteers and anyone acting on their behalf, from all claims, liabilities, demands, and causes of action, known or unknown, fixed or contingent, arising in tort (including but not limited to personal injury or death), contract, common law, statute, regulation, ordinance or otherwise, which I may have or claim to have, directly or indirectly, as a result of my participation in the Construction Derby®.

I hereby irrevocably grant to Rebuilding Together, in any media now known or later developed, a royalty free license to use my name, likeness, biographical material and voice as well as pictures and images of me, including computer generated drawings and images in associations with the production, promotion and marketing of the Construction Derby® throughout the world without any claim to compensation.

I represent and warrant that I have carefully read this agreement and fully understand all terms and conditions set forth in the Construction Derby® Rules Book 2009, and I agree to abide by all such rules, terms and conditions. I am aware that this is a release of liability and a contract between myself and Rebuilding Together and sign it of my own free will.
